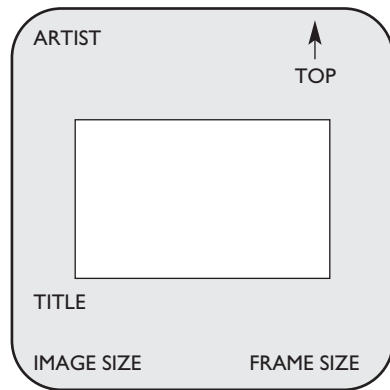

Notification of acceptance will be mailed by August 11, 2008. Slides of rejected paintings will be returned.

## LIABILITY

Neither South Shore Art Center nor New England Watercolor Society is responsible for any damage or loss.

## FRAMING

Work must not exceed 44" in any direction, including frame; and must be ready for hanging, professionally and sturdily presented under Plexiglass. **WHITE AND OFF-WHITE MATS ONLY.** No screw eyes and/or wire hangers visible from front of piece.

New England Watercolor Society or South Shore Art Center has the right to refuse any painting that is not professionally presented and/or does not meet the above specifications.

## ELIGIBILITY

- Open to any artist residing in North America and Hawaii
- All work must be entirely original, on paper; and done with only water soluble media (collage with no other media is acceptable) NO class work or work done under a teacher's supervision, computer generated work, prints, copies.
- Art may not be withdrawn early, and NO changes in pricing or catalogue information may be made after acceptance.

*NOTE: The Screening Committee has the right to refuse any painting that does not meet the stated specifications or is not accurately represented. **No work exhibited in past New England Watercolor Society shows is eligible.***

## JUROR OF SELECTION AND AWARDS

**DON ANDREWS, AWS**, is and active member and past board director of the American Watercolor Society. His paintings have received numerous awards in national watercolor competitions, including three awards from the American Watercolor Society.

Don is the author of the book, "Interpreting the Figure in Watercolor" and "Rough Sketches: Short Stories of a Traveling Artist" as well as the video "Making Watercolor Glow." His new book, "Interpreting the Landscape in Watercolor" has just come out. He is also featured in the Watson Guptill publication "Everything Your Ever Want To Know about Watercolor" and has numerous feature articles published in American Artist magazine and the Watercolor issue of American Artist.

## DELIVERY OF ACCEPTED WORK

Shipped work must arrive at the agent by **September 9**. Handling fee of \$50. Shipping instructions will be sent on acceptance into the show. Hand delivered work must arrive at SSAC on September 15 & 16, 10 am to 5 pm.

**All work must be for sale.**

A commission of 40% is due on all sales.
